John Devaney

Dean of the School of Social and Political Science
University of Edinburgh

Professor John Devaney, Centenary Chair of Social Work and Dean of the School of Social and Political Science, University of Edinburgh

I joined the University of Edinburgh in January 2018 as the Centenary Chair of Social Work, later becoming Dean and Head of the School of Social and Political Science. I am a qualified social worker with practice, managerial and policy experience relating to all forms of family violence. I have provided specialist advice on domestic abuse to various national governments and to the European Union. I was also recently a member of the Scottish Government's working group on misogyny and the criminal law.

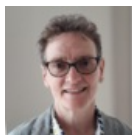
Are we in danger of going backwards? The struggle (and opportunities) to address domestic violence and abuse within a European context in a period of political, economic, and social contestation

The past thirty years has seen significant positive developments in Europe in understandings of domestic violence and abuse. This has resulted in both national governments and supranational bodies introducing laws and strategies aimed at providing a greater range of protections and supports for adult and child victims, while also seeking to ensure that individuals who cause harm are held accountable. However, the European political project is being contested, and with it so are the fundamental social and civic protections associated with this.

In this presentation I will chart the progress made in recent years, explore the struggles that are becoming apparent in the discourses about equality and protection for victims of domestic violence and abuse, and look forward to possible opportunities to resist and influence the diminution of rights and protections.

Catherine Donovan

Professor in Sociology
Head of Department
Durham University

Catherine Donovan is Professor of Sociology and Head of the Sociology Department at Durham University. She has researched the intimate and family lives of lesbians, gay men, bisexual women, and men, and, more recently trans+ folk for over twenty years. For most of that time her focus has been on their victimisation through, and perpetration of domestic abuse including sexual violence. She conducted the first study anywhere comparing love and violence in heterosexual and 'same-sex' relationships with Prof Marianne Hester (Donovan and Hester 2014); and the first study focussing on the use of violence and abuse by LGB and/or T+ people with Dr Rebecca Barnes (Donovan and Barnes 2020). She has collaborated with colleagues in Australia on some of the first research exploring the link between domestic abuse in LGB and/or T+ relationships and the abuse of companion animals. Catherine is currently working with the Drive Project in the UK on developing best practice for working with perpetrators of domestic abuse who are LGB and/or T+. More recently, Catherine has begun to research hate incidents/crime and, with colleagues, has drawn on the conceptual work behind coercive control in domestic abuse to describe hate relationships where perpetrators who live near those they victimise, repeatedly enact hate incidents with profound impacts for their mental and physical health and wellbeing. Catherine has also conducted research on student victimisation by violence and abuse, student and community active bystander interventions and Higher Education responses to students' victimisation.

Bringing Minorities into the Mainstream: Contributions of feminist research into domestic abuse in the relationships of LGB and/or T+ people to field

Intersectional feminists make the case that understanding domestic abuse cannot only rely on a gender-based analysis: structural inequalities based on 'race', social class, ability and capacity, age, citizenship status must be included to understand victimisation and help-seeking. Yet often the findings and conceptual development resulting from research with minoritised communities is perceived to have relevance only for those communities. Donovan and Hester (2014) argue that a public story of domestic abuse constructs the problem of domestic abuse as a problem of the physical violence of big, 'strong', cisgendered, heterosexual men for the small, 'weak', cisgendered heterosexual woman. Women who perpetrate, men who are victimised, those not experiencing physical violence, those who are not cisgendered and/or heterosexual are rendered invisible. I make the argument that findings from research on domestic abuse in the relationships of LGB and/or T+ people have relevance beyond these communities.

Guðrún Kristinsdóttir is professor emerita at the School of Education, University of Iceland. Guðrún has cooperated most with partners in Northern Europe, working in Denmark, Iceland, and Sweden, furthermore with colleagues in Australia and Canada. She is a former Associate Professor, University of Warwick, UK; earlier a board member of Gender Studies, Umeå University, Sweden, was a longstanding EB of the journals *Nordisk Sosialt Arbeid*, and *Nordic SW Research*. She has worked in projects financed by the Nordic Council of Ministers, and on tasks for several health and social authorities, and NGOs. Main research areas: Gender and IPV; children's well-being and child foster care. She is author of books and articles and edited an awarded book on children's perspectives on DV. Recent writings are handbook on DV for school staff, a guidance on children's research participation and a study on male perpetrators of IPV. Guðrún engaged in establishing the Swedish and the Icelandic SW Research Associations. She participated in feminist activist projects, from the 1970's onwards.

Intimate partner and employment-based violence in Iceland in precarious times: Two research projects

Globally, violence against women has increased during the COVID-19 global pandemic and raised new barriers to building inclusive societies. Furthermore, political, and ideological crises arising from the Ukraine war have raised further challenges. In the context of Iceland, there has been a 30% increase of police notifications of domestic violence during the last two years, compared to last 5 years average. Similar increase was observed for sexual abuse notifications against children. This paper draws on two research projects on violence against women funded by The Icelandic Research Fund and The Gender Equality Fund. Both encompass various albeit important perspectives. Empirical aims are general, to add to knowledge on domestic violence against women as well as structurally related aspects of violence. Practical aims are to inform policy by highlighting what works well in support measures. The first project focuses on perpetrators of violence in intimate relationships, drawing attention to factors such as masculinity, fathering, young people, and discursive formations of violence and subjects of violence. Data is based on interviews, discourse analyses of mass media material and surveying statistics. The second project focuses on intimate partner and employment-based violence of (im)migrant women. It aims at understanding the depth and prevalence of physical, racial, and psychological violence against immigrant women in Iceland. Data is based on survey findings, narratives, and interviews with immigrant women and service providers, and a critical discourse analysis of mass media and legal proceedings. Topics of these two projects are understudied in Iceland. In both projects, we employ a nuanced analysis, to simultaneously understand experiences and provisions. It is imperative to analyse hidden factors that reproduce and maintain values that legitimize use of power and control that lead to various forms of violence and to contextualize findings, among other as regards prevailing precarity of current times.

Heidi Stöckl is a professor of Public Health Evaluation in the Medical Faculty at the Ludwig-Maximilians-University. Her main research interests are the prevalence, health effects and risk and protective factors of intimate partner violence, sexual violence and intimate partner homicide. Her work focuses in particular on violence during pregnancy and against older women. She is currently conducting a longitudinal study on violence against women in Tanzania and conducted the first survey on intimate partner violence during pregnancy in a maternity ward in Germany.

Pregnancy and reproduction from an intimate partner violence and public health perspective

Intimate partner violence affects women and children across the world and pregnancy is no exception. This keynote lecture will summarize existing evidence on the prevalence on intimate partner violence during pregnancy globally, discuss the key risk and protective factors for it and its health consequences for both the mother and the child. It will expand existing theories to explain why precarity caused by, for example, COVID-19 or inflation can increase levels of violence by their partner, especially among vulnerable and marginalized populations, such as adolescents, poor and refugee women. As intimate partner violence often starts long before pregnancy, the keynote will also consider its influences or limits women's reproductive decisions making. COVID-19 has brought forwards innovative responses to prevent and address intimate partner violence and its applicability will be reviewed in light of other emergencies and precarities.

Ilona Michailovič, PhD is an expert of victimology and an associate professor at Vilnius University, Lithuania. With more than 20 years of research in criminal justice, she focuses on domestic violence, stalking, sexual harassment, restorative justice and mediation, discrimination and human rights. Dr. Michailovič has led several national research projects with regard to restorative justice, domestic violence and multi-agency cooperation by applying an integrated approach to domestic violence. Currently, I. Michailovič is a member of the Equal Opportunities Researchers' Network supporting the Ministry of Social Security and Labour of the Republic of Lithuania. She is also a member of the Victimology Working Group of the European Society of Criminology and European Forum for Restorative Justice.

Focusing on restorative justice and mediation in the context of domestic violence and abuse

Despite the benefits of restorative justice and mediation, recognized both by international legal standards and research, many experts and victim support services remain sceptical about the applicability of mediation in cases of domestic violence and abuse against women. For example, the CEDAW Committee urged Lithuania to end the use of reconciliatory mediation for victims of domestic violence and refrain from adopting reconciliatory mediation in the criminal process, given that such procedures may increase the vulnerability of women who are victims of violence (CEDAW/C/LTU/CQ/5).

In addition, in the context of recent events in Europe, domestic abuse can leave survivors in a precarious situation in regard to their welfare. Therefore, especially high standards of mediation practice should be supported. Accordingly, restorative justice professionals must be particularly trained on domestic violence and abuse, seeking protection of survivors.

Susana Pavlou has over 15 years of experience in research, policy development, and policy monitoring and evaluation with expertise on gender equality and violence against women.

She is widely recognised as a gender equality expert and has served as a senior researcher on a number of projects and studies commissioned by the European Institute for Gender Equality (EIGE), the European Parliament, UN Women, and the Council of Europe, among others. She has served as National Expert for the Network of Experts in Gender Equality, Social Inclusion, Health and Long-term Care (EGGSI), and as Independent Expert for DG Employment's Mutual Learning Programme (MLP). She has also served as Expert for the EWL Observatory on Violence against Women, and as Board Member and member of the Executive Committee of the European Women's Lobby. She is currently President of the national Advisory Committee for the Prevention and Combating of Family Violence and Vice President of the WAVE Network. In 2019, the Council of Ministers appointed her to coordinate the establishment the "Woman's House" a multi-agency, multi-disciplinary centre that will providing integrated services to victims of violence against women and domestic violence.

Susana has co-authored or contributed to a number of publications, including research reports, book chapters and journal articles, and conducted training seminars and workshops on a range of gender equality issues. She holds a BA in Political Science from the State University of New York at Stony Brook and an MSc in International Politics with an area concentration in the Middle East from the School of Oriental and African Studies (SOAS), London University.

Emerging evidence and quantitative data relating to previous pandemics and natural disasters indicate that the prevalence and severity of gender-based violence against women, particularly sexual and domestic violence, is exacerbated in times of crisis. As documented extensively, COVID-19 and associated restrictions and social isolation had a devastating impact on the 'hidden pandemic' of violence against women and domestic violence leading to a dramatic rise in reporting. While most EU Member States took some form of action to support and protect women victims of intimate partner violence and their children in response to Covid-19, there is diversity in both measures adopted and impact. To a great extent, however, innovations in responses to the crisis were led by women's specialist services (WSS) across Europe. Despite this, insufficient attention has been brought to the impact of the crisis on the capacity of WSS and front-line professionals to effectively respond to increased demand for services under crisis conditions. The project "TRUST – Towards Replicable forms of Support and Tools for Women's Specialist Services in crisis situations" aims to assess measures adopted during the COVID-19 from a victim-centred and gender sensitive perspective and propose new operational models to ensure resilience of WSS to meet the new reality and in preparation for future emergencies/crises.

Lucas Gottzén is a Professor at the Department of Child and Youth Studies, Stockholm University. His research takes feminist and critical perspectives on youth, gender, and sexuality, particularly focusing on young and adult men's domestic violence. He is the author and editor of several academic monographs and volumes, including the lead editor of *Routledge International Handbook of Masculinity Studies* (2020, with Mellström & Shefer) and *Men, Masculinities and Intimate Partner Violence* (2021, Routledge, with Bjørnholt & Boonzaier).

Men, Masculinities and Domestic Abuse Perpetrators: Precarity, Masculinity Threats and Remasculinization Decades of neoliberalism has put the male breadwinner model under considerable pressure so that masculinity now provides limited protection against the social and economic losses that have afflicted the working and middle classes in many Western societies. Hegemonic masculinity has also been challenged by feminists and marginalized groups demanding recognition and redistribution. These parallel processes have left many men feeling marginalized and their masculine identity threatened, as white men often see themselves entitled to their social and political privilege. By drawing on research with young and adult partner-violent men in Sweden, I will demonstrate how men's experiences of precarity may influence domestic violence. The interviewed men recurrently linked their social and economic problems to their abuse and narrated how immediate threats to their gendered position at times lead to violence. The discussion is expanded by showing how activists within the 'manosphere' advocate woman abuse as an adequate response to masculinity threats. Through this, I argue that domestic violence becomes a means of remasculinization of society and individual men.

Ragna Björg Guðbrandsdóttir is a specialist in children's affairs at the District Commissioners Office of the Reykjavík Metropolitan area. The department of Children's Affairs services the whole of Iceland in mediation in custody cases. Ragna recently relocated from Bjarkarhlíð – Family Justice Center for survivors of violence, an NGO opened in 2017, with active participation of governmental ministries, City of Reykjavík, the Reykjavík Metropolitan Police and NGOs working with survivors of violence. Ragna was a project manager for five years and took an active role in developing the multi-agency program serving adult survivors of all kinds of violence and for all genders. Prior to this Ragna lived in Copenhagen and was working with *Reden* International, an NGO working with women that have been trafficked into prostitution. Ragna was project manager in 2011 for two years of a pilot project "keeping the window open" for survivors of domestic violence with a special focus on children witnessing domestic violence. The pilot was a collaboration between the Metropolitan police and CPS, working together when the police was called to the scene of domestic violence. Ragna worked for eight years at Barnahús in Reykjavík and took part in the developing the resource for children suffering from sexual abuse which has now developed into being an ongoing service for children suffering from violence and has been acknowledged as a best practice model in Europe. Ragna has a degree in psychology from the University of Iceland and graduated from the University of Washington in Seattle as a Clinical Social Worker – MSW.

The severity of post-separation violence when it comes to domestic violence

Formal recognition of the negative impact on survivors of domestic violence has increased both professionally and as regards public awareness over the years. In my lecture I will draw on experience from a project in multi-agency settings, working with survivors of domestic violence. The project emphasizes how working together to take down walls between services and systems can make the difference in seeking help and gaining hope for life free from violence.

The pilot project Bjarkarhlíð, Family Justice Center for survivors of violence, opened in Reykjavík in 2017. It later developed into an ongoing program. Leading this project in cooperation with the city of Reykjavík, the Ministry of Justice and Welfare, the Reykjavík Metropolitan police, and different grassroots organizations, working with survivors of violence convinced me how much hope we could give by working together across agencies. It is empowering for survivors to be able to visit and get support and counseling at only one location.

The post-separation violence is something that needs more attention in future work and increased support for survivors leaving abusive relationship. Post-separation violence manifests itself differently: to manipulate and threat, to convince the victim to return, to continue to exert control by harassment and surveillance, to prevent the victim to return, to continue to exert legal proceedings, to control via shared parenting, escalation of physical violence, to take revenge by financial violence and voluntary self-improvement, or simply to "win" and have the last word.
